Annual Report

For the period 1/1/18 through 12/31/18

1. The Polk County Pretrial Services Program whose administrative offices are located at 1755 HWY 17 S, Bartow, FL 33830, consists of a staff of twenty-three and half (23.5) individuals and is funded by the Polk County Board of County Commissioners. Funding for the fiscal 18/19 Oct-Sept year was \$1,179,737
2. The operating and capital budget was \$106,505/\$2000. The percentage of the pretrial release program's total budget representing receipt of public funds was 100%.
3. The amount of fees paid by the defendants to the pretrial release program, (doesn't apply)
4. The number of defendants assessed and interviewed was 27, 705.
5. The Pretrial Service Program recommends nonsecured release to the First Appearance Judge only if the defendant meets certain criteria.
6. The number of defendants assessed and interviewed for pretrial release that were declared indigent by the court was 2, 578.
7. Of the 1,025 defendants released on nonsecured release 90 individuals failed to attend a scheduled court appearance and were issued Failure to Appear Warrants. (Attachment #1 shows names of the individuals as well as the date upon which they were terminated. Weekly register reports are filed with the Clerk of Courts at www.polkcountyclerk.net.)
8. Of the 1,025 defendants released on nonsecured release 55 individuals were rearrested. (Attachment #1).
9. The daily cost to house an inmate in the Polk County Jail is reported at \$ 39.99 plus \$2.5 per day per inmate in 2018.
